FRED2 The Project



'FRED2' has the ambitious goal of initiating an intensive cooperation between the academic world (national and European universities) and the Anti-Fraud Coordination Services (AFCOS) of the countries of the Union (including Italy) for the establishment of a permanent study table on the subject of European Funds.

The history, general guidelines and possible developments of the FRED2 project were presented.










The Project aims to:

- undertake an experiential co-lab-learning course (with the participation of academics, Law Enforcement, AFCOS, and practitioners in the field) that, through more effective know-how, can improve the identification of new fraud risks and the comparison of control strategies in the area of public budget support;
- establish a special task force, composed of academics and professionals, with the aim of producing a "pilot study" for the analysis of risk profiles;
- create a "European Anti-Fraud Observatory" which will be able to give sustainability to the development of a new network (networking) of useful contacts and targeted relations to improve the knowledge of the phenomenon of fraud.
- promotional and dissemination material planning and realisation for supporting the previously mentioned goals.

FRED2 Task Force



Task force is created by a European academicpractitioner mixed group, that during the project will produce a research study useful for detecting and predicting behaviour and risk profiles that characterise the deviated qualitative and financial use of European funds.

They will operate during the cycle of workshops and study visits expected by the project defining the basis of a map of concepts that will characterise the future pilot research study. At the end of the cycle of webinars, workshops and study visits, the so-called concept map will be created.
