Next Generation EU: preliminaries

Next Generation EU is the EU's €800 billion (current prices) temporary recovery instrument to support the economic recovery from the coronavirus pandemic and build a greener, more digital and more resilient future.

It is rooted around six pillars:

- •Boost the **green transition** through the promotion of renewable energies, sustainable mobility and more
- Accelerate digital transformation through greater digitisation of public services and the wider economy
- •Reinforce **social infrastructure and services**, while reducing territorial disparities
- •Enhancing access to **advanced education** and training in skills relevant to the future economy
- Support inclusive growth, research and development, and innovation for all
- Ensure modern, efficient and accessible healthcare services.


Pillar 1: make it green

- Europe is on track to become the first climate-neutral continent by 2050

 we will produce no more greenhouse gases than our ecosystems can naturally absorb. With Next Generation EU, we will invest in environmentally-friendly technologies, roll out greener vehicles and public transport, and make our buildings and public spaces more energy efficient.
- But we also need to protect our natural environment. We will:
 - improve water quality in our rivers and seas, reduce waste and plastic litter, plant billions of trees and bring back the bees
 - create green spaces in our cities and increase the use of renewable energy
 - make farming more environmentally-friendly so our food is healthier.






Pillar 2: make it digital

 The RRF supports reforms and investments aiming to promote the roll-out of very high capacity networks, the digitalisation of public services and government processes, the digitalisation of businesses, in particular SMEs, the development of basic and advanced digital skills as well as measures supporting digital-related R&D and the deployment of advanced technologies.

Beyond a general requirement to contribute to the digital transformation pillar, each Member State must dedicate at least 20% of its recovery and resilience plan's total allocation to measures contributing to the digital transition or to addressing the challenges resulting from it.








Pillar 3: Smart, sustainable and inclusive growth








Pillar 4: social & territorial cohesion

One of the key objectives of the RRF is to promote social and territorial cohesion and to mitigate the social impact of the crisis. This should also contribute to fighting poverty and tackling unemployment, enabling Member States to rebound while leaving nobody behind. The reforms and investments supported by the RRF should contribute to improving **social and territorial infrastructure and services**, including social protection and welfare systems, the inclusion of disadvantaged groups, support employment and skills development, and lead to the creation of high-quality and stable jobs.






Pillar 5: Health, and economic, social and institutional resilience

The COVID-19 crisis has highlighted the importance of reforms and investments in health. It will also be crucial to invest in economic, social and institutional resilience to increase crisis preparedness and response capacity.

Member States have included in their plans reforms and investments to improve the resilience, accessibility and quality of health and long-term care, including measures to advance their digitalisation, and to increase the effectiveness of public administration and judicial systems.








Pillar 6: Policies for the next generation





An overview of the actions (investment/reform) by country




Italy allocated almost € 195 billions of funds (roughly 10% of its GDP) divided in:


Milestones and targets per type of measure


